Any child, aged 0-3, suspected of having a visual or hearing impairment may be referred to the MICE Program. Each child will then be referred to the local Area Agency to do an intake assessment and set up a developmental evaluation. The program serves children (age's birth to three) for whom there is a concern relative to vision and/or hearing. MICE is administered by the Parent Information Center in cooperation with the Bureau of Developmental Services.

SBVI is a statewide program that offers comprehensive services to enable blind and visually impaired individuals to secure employment and personal independence. Services include - vocational rehabilitation counseling, assessment, skills training, technology and rehabilitative engineering and job placement. Eligibility: Must meet New Hampshire vocational rehabilitation eligibility criteria. Clients may be referred at age 14.

Services are funded federally without cost to the individual. Available to individuals ages four through adult. Temporary disabilities accepted.

Here is some of what they offer:

- *Future Reflections*, a magazine for parents and educators of blind children. This publication of the National Organization of Parents of Blind Children offers insights into blindness as well as practical guidance in the day-to-day aspects of raising a blind child. The magazine addresses topics specific to blind youth of all ages—infants to teenagers.
- A Braille pen-pal service (Slate Pals) for blind youth.
- NOPBC provides parents with current information about the Individualized Education Plan (IEP) process and the Individuals with Disabilities Education Act (IDEA) and partner in the Families and Advocates Partnership for Education (FAPE) project. The objective of this project is to disseminate accurate information about the 1997 amendments to IDEA.

- NOBPC also distributes free literature, establishes cane banks so parents may trade in old canes for new ones, consults with legislators about the needs of blind children, provides assistance to parents and blind children whose rights have been denied, and much more.
